TWELFTH ANNUAL MEETING OF SUBSCRIBERS

TO THE

Geelong Insirmary and Benevolent Asylum,

Held at the Institution on Tuesday, 26th January, 1864.

AT the request of the Chairman, the Secretary, Mr. MIDDLEMISS, read the Advertisement calling the Meeting, and the Twelfth Annual Report and Financial Statement of the Committee of Management; and it was

Moved by Rev. James Henderson, Seconded by J. R. Morris, Esq., J.P.

1. That the Report now read be adopted and printed, together with the List of Diseases treated, the Vital Statistics, the List of Subscriptions, and the Rules and Regulations of the Institution.

After the erasure of a few words from the Report the Resolution was carried.

At the request of the Meeting the Secretary read the list of Attendances of the Committee during the year.

TWELFTH ANNUAL REPORT.

In reviewing the operations of the Institution during the past year, the Committee of Management of the Geelong Infirmary and Benevolent Asylum cannot but congratulate the Subscribers on the success which, under God's blessing, has attended them. The Institution, during the year, has continued to render effective aid in ameliorating the condition of the sick and destitute; and the Committee are proud to be able to

report so favorably.

From the Vital Statistics, the following particulars are taken. At the end of 1862, 118 persons—79 in the Infirmary and 39 in the Benevolent Asylum—remained in the Institution. During the past year, 590 have been admitted to the Infirmary and 36 to the Benevolent Asylum; making 744 persons who have been inmates of the Institution during 1863. Of this number, 44 died in the Infirmary; 551 were discharged cured or relieved; and 64 remained at the close of the year. 8 died in the Benevolent Asylum; 17 left of their own accord; and 50 remained. 1,648 out-patients were treated during the year, 85 of whom remained on the books at the end of the year. Thus 2,422 persons have received the aid of the Institution during the past year.

The daily average number of inmates has been 120.1.

It is with pleasure that the Committee state that the death rate is less for the past year than for any previous year. This will be seen by reference to the List of Diseases and Result of Treatment.

Of the more prevailing diseases there have been:—Rheumatism, 70 cases; Consumption, 22; Ophthalmia, 33; Disease of Heart, 21; Paralysis, 14; Bronchitis, 7, &c.; and there has been 34 cases of Fracture, 26 of Contusion, and 25 of Gunshot and other Wounds.

Of the 590 persons admitted to the Infirmary, 149 were females, and 441 males, the native countries of whom were—England, 219; Ireland, 216; Scotland, 63; Switzerland, 15; Wales, 7; Tasmania, 5; Denmark, 5; New Zealand, 5; Germany, 3; United States, 3; China, 3; Sweden, 3; Prussia, 3; Canada, 2; Poland, 1; Holland, 1; Spain, 1; France, 1; Austria, 1; Channel Islands, 1; East Indies, 1; Dominica, 1; Italy, 1; Bermuda, 1; New South Wales, 1; South Australia, 1; and 6 were not known.

The different sects were:—Church of England, 261; Roman Catholic, 157; Presbyterian, 68; Wesleyan, 21; Lutheran, 16; Calvanists, 6; Baptists, 4; Jews, 3; Congregationalists, 2; Budists, 3; Bible Christian, 1; Moravian, 1; and there were 9 of no religion, and the remainder not known.

The Receipts have been £6,488 13s. 5d.; and the Expenditure, £5,424 18s. 11d. A shipment of drugs came to hand at the end of the year, and sundry contracts for clothes were also taken in December. This will explain an apparent increase in these particulars. The average cost of each patient has been less than in the previous year. The Committee have to thank the Contributors for their liberal support, and particularly those Congregations who responded to an appeal to enable them, at the close of the year, to make up the sum required to claim the Government Grant.

It has been found necessary to do certain painting and repairs to the Institution, and to call for tenders for the erection of a building which will be at once a shelter for the patients and useful for other purposes, and which will serve to collect rain water. A considerable sum has hitherto been paid annually for water, and it is hoped this expense may be avoided.

While referring to the Finances, the Committee deem it appropriate to refer to the death of the late Treasurer, John Sleath Hill, Esq., who held the office of Treasurer for eleven

years Mr. Hill was also a Trustee of the Institution, and Chairman of the House Committee, from whose meetings he was scarcely ever absent. Mr. Hill was a firm friend of the Institution, always taking the greatest interest in its success, and ever solicitous for the comfort and well-being of the patients His loss is deeply felt, and his death greatly deplored, by all connected with the Institution.

The Committee have again to offer their thanks to Messrs. Foster Shaw and Walshe, whose services as Honorary Medical Officers have been willingly and continuously rendered. Messrs. Shaw and Walshe are elegible for re-election. Dr. Baylie also volunteered his services, which were thankfully accepted by the Committee.

In the month of September last, it came to the knowledge of the House Committee that complaints made by patients to visitors had not been communicated to any of the Officers of the Institution, nor to any member of the Committee, but had been privately circulated outside, to the detriment of the Insti-They, therefore, directed that the attention of visitors should be drawn to the regulation which requests them to sign their name in the Visitors' Book, and invites them to make remarks therein. The Resident Surgeon also complained that the conduct of the visitors referred to caused annoyance and ill-will among the patients and servants of the Institution, and was destructive of order and discipline. He, therefore, asked the authority of the House Committee to enforce more rigidly the regulation as to visitors. The House Committee, finding the Rules sufficient to meet the requirements of the case, did not see cause to interfere, but intimated to the Resident Surgeon that it was not only his right, but his duty, to maintain the efficiency of the Institution, by a judicious enforcement of the Rules. On the Resident Surgeon acting in accordance with that intimation, several of the ladies who had been in the habit of visiting left off attending the Institution-a result which was quite unforeseen by the House Committee, and deeply deplored by them.


Subsequently, it was ascertained that a document, containing among other statements injurious to the Institution, charges of

immorality against certain of the Officers, had been prepared by one of the inmates of the Benevolent Asylum, and given to one of the lady visitors, and was shown to several clergymen of the town. The Secretary took steps to secure possession of this document; and, on the same being placed before the House Committee, it was determined that a searching investigation into the truth of the charges should be made. This was done; and the evidence showed that there were no grounds for the imputation of immorality. This decision was confirmed by the General Committee, by whom the whole of the evidence was reconsidered. In the course of the examination, however, the Committee ascertained that the House Steward, the Matron, and the Head Nurse, had not been performing their duties with sufficient firmness, and with sufficient courtesy towards each other; and it was considered requisite that they should be cautioned in regard to the discharge of their duties in future, which was accordingly done.

The Committee, in concluding their labors for the year, are rejoiced to have it in their power to report that the internal management of the Institution is in a state of great efficiency; and they hope that it will continue to increase in usefulness during the year that is begun.

GENERAL RULES.

I. That the objects of the Infirmary be to afford Medical and Surgical aid to poor persons requiring it, for a limited number of paying patients, and for casualities; but that no persons who shall meet with asualities, and shall be found able to pay for Surgical aid, shall receive urther than temporary gratuitous assistance. That the object of the Benevolent Asylum be the reception of the poor and distressed, with a new to afford them consolation and assistance.

OBJECTS.

II. That a portion of the Building shall be set apart for the purposes Appropriation of of the Infirmary: and the remainder for the purposes of the Benevolent Asylum, at the discretion of the Committee.

III. That the Government of the Institution shall be vested in a Institution, how President, two Vice-Presidents, five Trustees, a Treasurer, Governors, ind Subscribers, as hereinafter described.

QUALIFICATIONS AND PRIVILEGES OF GOVERNORS AND SUBSCRIBERS.

IV. That every Benefactor of £50 or upwards be a Life-Governor, and every annual Contributor of £20 an Annual Governor, with liberty of having one in-patient, or three out-patients, always on the books of the Institution, subject to the approval of the Committee of Management hereinafter mentioned, and provided that the funds of the Institution admit of the reception of such patients; and any public Institution contributing £50 in one sum shall be entitled to the privilege of a Governor for ten years from the date of such contribution.

Governors.

V. That the Executor, or if more than one, the first named Executor Executors, where under any will by which a bequest of £50 or upwards shall be made to the Institution: and every Minister raising by one or more collections in Ministers raising his Church, in any one year, the sum of £20 or upwards; and any other person, contributing a similar amount from any other source, shall have the rights and privileges of a Governor for one year only, commencing from the January following.

VI. That every Benefactor of £25 or upwards, in one sum, be a Subscribers. Life-Subscriber, with liberty of having one in-patient and three outnationts admitted annually; and every contributor of £1 18, and upwards annually, an Annual Subscriber, with liberty of having patients admitted as follows :- Annual Subscribers of £1 1s. to have four One patients' tickets; of £2 2s., one In-patient and two Out-patients £3 3s., two In-patients and four Out-patients : of £5 5s., four In-patients and eight Out-patients; of £10 10s., eight In-patients and eight Out patients. Recommendations for admission to be subject to the approve of the House Committee, and to be made by Tickets only, to be issued by the Secretary or Collector, to Subscribers, at the time of their become ing such, and provided that whenever any recommendation cannot be acceded to, from want of room, or other cause appearing to the Com mittee, the ticket used in such recommendation shall be reclaimable by the Subscriber issuing the same. These tickets shall only be used for the recommendation of persons unable to pay for Medical attendance and shall only be available till 31st January, in the year after that in which they are issued.

Subreriptions, when due.

Subscribers ontitled to vote,

VII. That the Annual Subscriptions must be paid in advance for the current year, such year to be computed from the first day of January in each year, and no Governor or Subscriber will be entitled to any privilege until the subscription be paid. And no person shall be qualified to vote at any meeting of Subscribers, unless he shall have been a Subscriber for the space of six months, previous to such meeting; provided always, that where a Subscriber shall have paid his Subscription for the year immediately preceding the year in which any public meeting shall take place, the payment of his Subscription for the then current year any time before such meeting, shall entitle such Subscriber to vote, as required by Act of Council, 24 Vic., No. 116.

Annual 'Meeting of Subscribers VIII. There shall be an annual meeting of the Subscribers in the month of January in each year, at which all retiring Honorary Officers of the Institution shall be elected for the ensuing year.

IX. That no person shall vote at any meeting while he is a salaried officer, or pupil of the Institution.

General Laws.

X. That no general law, nor any repeal of, or alteration in, the existing laws shall be valid, unless the same shall have been passed at the annual or special Meeting of the Subscribers.

Committee of Managoment. XI. The Committee of Management shall consist of the President, Vice-Presidents, Trustees, Treasurer, and Eighteen Governors or Subscribers, to be elected mutually; six to form a quorum; and they shall have power to fill up vacancies that may occur in their number during the year, subject to Rule XIV.

XII. It shall be competent at any time for the Committee of Man-Special Meetings agement, at which at least eight members shall be present, or for nine or more Subscribers, by a writing under their hands, to require the Secretary to summon, at the expiration of fourteen days, a Special Meeting of Subscribers' the occasion of calling such meeting being stated in the requisition; and no business shall be transacted at such Special Meeting, except that for which it shall have been summoned. 'Every such meeting to be called by the Secretary, by advertisment in one of the public newspapers, published in Geelong, within three days of his receiving such requisition. Twelve Subscribers shall be necessary to form a General or Special Meeting.

XIII. That all Meetings of Subscribers be called by the Secretary, Meetings of Subby advertisment in one of the newspapers published in Geelong, at least one week before the day of meeting. ,

XIV. In the event of any vacancy in the office of President, Vice- Honorary Officers Presidents, Treasurer, Trustees, or Auditors, the Election of a successor shall take place at a Special Meeting of Subscribers, to be convened by the Committee of Management, which Election shall be by voting-tickets, as enjoined by Act of Council, 11 Vic., No. 59, section 9.

XV. And it shall be lawful at all meetings of Subscribers, for any Vote by Proxy. Life-Governor or Life Subscriber who became such previous to 1861, as enjoined by Act of Council, to Vote by Proxy, such Proxy being also a Subscriber duly qualified; provided that such Proxy shall have his authority in writing, signed by the Governor or Subscriber; and such authority shall only extend to the one meeting especially named therein. Governors to have three votes; Life Subscribers three votes; Annual Subscribers of £10 10s, three votes; £5 5s. two votes; of £1 1s, and upwards to £5 5s. one vote.

COMMITTEE OF MANAGEMENT.

XVI. The Committee of Management shall direct the general Committee of Mabusiness of the Institution; shall frame Bye-Laws for its internal regulation, the same not being repugnant to the General Rules; shall have power to enter into all necessary contracts on behalf of the Institution Their duties and and direct payments to be made; and appoint and discharge all paid officers and servants of the Institution. They shall meet at the Institution on the first Wednesday in every month, and on such other days as they may appoint. They shall have power to admit patients, and to make regulations respecting them. The Chairman of Committee, in case of any equality of votes, to have a casting vote, but no deliberative vote.

XVII. The President, Vice-Presidents, Trustees, and Treasurer, shall be Members ex-officio of the Committee, provided they be qualified by subscriptions.

XVIII. The Committee of Management shall choose, from among themselves, a House Committee of five, three to form a quorum, who shall meet on Monday and Thursday in each week, at 4 o'clock, p.m., and oftener if necessary; and who shall have power to admit patients, to examine and pass and pay the house accounts, to engage and discharge servants, and to regulate the internal management of the Institution, under the direction of the Committee of Management.

Annual Report. XIX. The Committee of Management shall present a General Report of the affairs of the Institution at the Annual Meeting of the Subscribers.

Accounts when to be audited. XX. The Accounts of the Institution shall be Audited once in every year, and presented at the Annual Meeting of Subscribers.

HONORARY MEDICAL STAFF.

XXI. The Honorary Medical Staff shall consist of four duly qualified general practitioners to be elected annually. No one shall be eligible for the appointment unless he can produce a Diploma from a recognised British University, or from one of the Royal Colleges of Surgeons of London, Edinburgh, or Dublin, or the Faculty of Physicians of Glasgow, together with a certificate from the Medical Board of Victoria.

Charge of Patients and visiting.

XXII. The Resident Surgeon shall have the charge of all patients admitted; but the Honorary Medical Staff may visit the Institution at any time, and in case of their observing any neglect of or inattention to the patients it shall be their duty to report the same to the House Committee forthwith.

Rotation of duty.

XXIII. Two of the Honorary Medical Staff shall attend in weekly rotation, on such days, and at such hours as may be most convicent, for consultation on the treatment of the patients: and they shall arrange the rotation of attendance.

Consultations to be held.

XXIV. The Honorary Medical Staff of the week shall attend for consultation on all important cases; and should any capital operation be deemed necessary the whole of the honorary medical staff shall be summoned for further consultation (except in cases of emergency) previous to the operation being performed, when, if then decided on, the whole of the honorary medical staff shall be requested to attend.

ADMISSION OF PATIENTS INTO THE INFIRMARY.

Patients.

XXV. That accidents and such cases of decided emergency only as Admission—into in the opinion of the Resident Surgeon cannot be delayed, be received into the Infirmary at any time without ticket, but that the admission of patients, in ordinary cases, be restricted to Monday and Thursday in each week, or at special meetings of the House Committee, and then only on presenting a Subscriber's ticket.

ADMISSION OF PAYING PATIENTS.

XXVI. That Paying Patients be admitted on the usual days of Patients to be adadmission, without tickets, at the discretion of the Committee.

XXVII. That the amount chargeable to each patient shall be at the Amount to be discretion of the Committee; and shall be paid in advance, or at the charged. discretion of the Committee.

XXVIII. That the general rules and regulations of the Institution Rules applicable shall be applicable to, and strictly observed by, all paying patients to paying Parceived into the Institution.

PERSONS NOT ADMISSABLE.

XXIX. No pregnant female for the purpose of confinement; no Persons not adperson insane; no one having a contagious or infectious disease; no one subject to epilepsy; nor any one who, in the opinion of the Resident Surgeon, might receive equal benefit as an out-patient, shall be admitted; and no child under five years of age shall be admitted, except from an accident or for a surgical operation.

Admission of Innates into the Benevolent Asylum.

BENEVOLENT ASYLUM.

XXX. The admission of immates into the Benevolent Asylum is Admission of Inordinarily restricted to Monday and Thursday in each week, but a meeting of the House Committee may be convened at any time to consider authenticated cases of utter destitution.

XXXI. No pregnant female for the purpose of confinement; no Persons not adperson insane; no child under twelve years of age; no one having a missable. contagious or infectious disease, shall be admitted.

XXXII. Ministers of Religion shall have free access to persons of Ministers of Relitheir respective denominations, at such times as shall be appointed by gion. the Committee of Management; and when a patient requests that any minister may be sent for, his wish shall be immediately complied with.

In XXXIII. That the Instruction of the patients in the Institution be left to the recognised religious teachers of the various denominations to which the patients belong; and it shall be understood that controversian works be prohibited.

XXXIV. He shall attend all Special, General, and Committee Meetings; he shall take minutes of the proceedings, and transcribe them carefully into books to be kept for that purpose, and he shall carry out the directions of such Meetings in the particulars incident to his department.

Correspondence and Accounts. XXXV. He shall conduct the correspondence and other clerical business of his department, and he shall enter and keep the accounts of the Institution, under the direction of the Committee.

COLLECTOR.

collect and pay. XXXVI. He shall be under the direction of the House Committee, and shall collect subscriptions and donations to the Institution, and pay over the same to the Treasurer, at least once in every week, and render account of the amount received by him since the last payment.

ALTERATION OF RULES.

Alteration of Rules. XXXVII. These Rules shall not be altered, except at a Special or General Meeting of Subscribers, due notice of any proposed alteration having been given, in accordance with Rule 12.

RESIDENT SURGEON.

1. No Candidate shall be eligible for the appointment of Resident Surgeon unless he produces a diploma from either of the Royal Colleges of Surgeons of London, Edinburgh, or Dublin, together with a Certificate from the Medical Board of Victoria.

2. He shall reside in the house, and shall not leave it except on Regulations necessary occasions. He shall not be absent more than three hours at one time, or after Twelve o'clock at night, without the express leave of the House Committee. In case of absence, he shall inform the House Steward and Dispenser, and shall enter in a book kept for the purpose where he may be found.

3. He shall have the charge of all patients admitted, and shall Charge of the Pareport to the House Committee at its next meeting any patient who may have been disorderly. HOUSE STEWARD AND DISPENSER.

16. The House Steward and Dispenser shall live in the House, and Regulations specting temposhall not leave except on necessary occasions, and with the consent of rary absence. the Resident Surgeon. He shall not be absent for more than three

hours at one time, nor after ten o'clock at night, without the leave of the House Committee.

N.B.—He and the Matron shall never be absent at the same time.

- 17. He shall have the immediate superintendance of the Matron. Wardsmen, Nurses, and Servants, and shall see that they do their duty: vants; report and he shall enforce order, sobriety, personal cleanliness, neatness, and any failure to the Resident obedience to orders on their part. In case of any misbehaviour, disobedience, or neglect of duty, by any of them, he shall at once report the same to the Resident Surgeon or House Committee.

 - 18. He shall see that the Wards, and all other parts of the House. kept in a proper state of cleanli- and the grounds, are kept in a proper state of cleanliness and order.

19. He shall have the charge of, and be accountable for, the furniture, bedding, linen, glass, cutlery, cooking and kitchen utensils, medicines and stores; and he shall make an Inventory of the same in a book to be kept for the purpose, in which he shall regularly enter the receipt, loss or breakage of any article; and he shall, on the last days of June and December in each year, and at such other times as the House Committee may require, prepare and submit to the Committee an Inventory of everything under his charge; and he shall prepare an Inventory of everything placed under the charge of any Wardsman, Nurse, or Servant; and shall on either of them leaving the Instisution, require them to give an account of all that they may have had under their care,

Receive stores and supplies; and dispense the consumption, and daily enter the amount in a book. Oversight provisions. of stores, and utensils,

20. He shall receive the stores and supplies furnished by the Contractors and Tradesmen, and he shall see that they correspond in description, quality, and quantity with the tenders and orders; and in case they do not, he shall report accordingly to the House Committee at its next meeting; and he shall weigh and measure out the provisions and other necessaries required for the day's consumption, and he shall enter the amount regularly in a book to be kept for that purpose; and he shall attend to the cutting up and distribution of food to the patients when cooked; and he shall not suffer any of the provisions, utensils, or stores, to be wasted or carried away; and he shall prepare the usual

Patients' clothes monthly returns of diets, receipt and issue of stores, &c., and accounts and an inven- as may be required by the Committee; and he shall have the clothes of all patients cleansed on admission, if requisite, and he shall make out an Inventory of the same.

Dispense prescriptions.

21. He shall dispense the Prescriptions of the Resident Surgeon, and shall carry out the instructions of the Resident Surgeon in the Surgery, and otherwise fulfil the duties of Dispenser.

MATRON.

22. She shall be subject to the same regulations, respecting living in the house and absence therefrom, as the House Steward and D ispenser.

Absence.

- N.B.—She and the House Steward and Dispenser shall never be absent at the same time.
- 23. She shall see that the Nurses and Female Servants do their Superintendence of Nurses and duty; and shall report any neglect or disobedience of orders on their female servants. part to the House Steward and Dispenser.
- 24. She shall visit each Ward daily, and shall see that the beds, Visit and inspect the Wards daily. linen, and clothes of the patients, are clean and in good order; and shall cause such of the bedding, &c., as require it to be replaced by others and thoroughly cleansed and repaired where necessary.
- 25. She shall superintend the Laundry, and shall be accountable to the House Steward and Dispenser for the return from the Laundry of all clothes sent to be washed or cleansed, keeping an account of everything taken to the Laundry and received therefrom.

Laundry.

26. She shall see that all patients' clothes, as they are admitted, are Patients' clothes, cleansed and put carefully away; and shall enter in a book a list of all patients' clothes as they are received, and procure the receipt of each patient for their clothes when they leave. And shall not permit any of the patients' clothes to be removed from the store but in her presence.

27. She shall personally superintend the cooking of all food for the To superintend the cooking. inmates; and shall generally discharge the duties of Matron as shall be directed by the Committee.

WARDSMEN, NURSES, AND SERVANTS.

- 28. The Wardsmen and Nurses shall be constantly in their Wards, Attendance Wardsmen and and regular in their attendance upon the patients. Nurses.
- 29. They shall obey the Resident Surgeon, House Steward and Their deportment, Dispenser and Matron. They shall behave with tenderness to all the patients, with civility and respect to strangers; they shall withdraw from the Wards when the House Committee enter them, unless particularly requested to remain; and they shall take no presents or gratuity in money or otherwise from the patients, their friends, or strangers, who may visit the Institution, on any pretence whatever-Infringement of the Rule will subject to instant dismissal.

Permission temporary sence.

- 30. No Wardsman, Nurse, or Servant, shall leave the Institution without permission of the Resident Surgeon or House Steward and Dispenser.
- Personal cleanliness; by what and Nurses shall be particular to observe perness; by what sonal cleanliness; they shall have their respective Wards swept and morning Wards thoroughly cleansed, and all dirt and rubbish removed from them by 7 and dirt, etc., o'clock in the morning in the summer, and before 8 o'clock in the morning in winter.
- Breakfast. 32. They shall serve up Breakfast to the patients at 8 o'clock in the morning.
- Details to 38. They shall have the several chamber utensils scalded overy morning and scoured as often as may be necessary, and kept out of the wards during the day, unless specially required.

 34. They shall pay great attention to the bedding of the patients, and have the mattrasses thoroughly aired and dried when necessary, and the sheets, blankets, and counterpanes renewed as often as required.
 - 35. They shall not allow clothes to be hung, nor dirt, or anything to be thrown out of the windows.
- Medicines, diet, 36. They shall administer to the patients at the times directed, the medicines and the diet prescribed, and they shall not suffer them to take any which are not prescribed, and they shall be careful to explain to the patients the instructions of the Resident Surgeon.
- Regulations respecting visitors, or liquor of any kind; nor allow any portion of medicine
 or diet, or any other thing to be removed from the wards by the patients
 or visitors, without an order from the Resident Surgeon.
- Empty phials, etc. Food not used; geon all empty phials, gallipots, bandages, &c.; and to the Matron any Dispensary for articles of diet not consumed by the patients; and they shall attend at the Dispensary at the times appointed, to receive medicines and instructions.
- Watch and report 39. They shall watch attentively the state and symptoms of the patients' state and symptoms, patients, more especially in urgent or uncommon cases, and report these distinctly to the Resident Surgeon, or in his absence to the House Steward and Dispenser; or in case of females to the Matron.

- 40. They shall not admit any stranger into any ward without the Admission οř strangers. permission of the Resident Surgeon or the Secretary.
- 41. One Wardsman or Nurse in rotation shall be on duty from 8 Wardsman Nurse on night o'clock every night to 6 o'clock the following morning, and shall visit duty. each ward once in every two hours, or more frequently if necessary, and shall pay due attention to such patients as may require it, and, should there be occasion, shall communicate with the Resident Surgeon.
- 42. All Wardsmen, Nurses, and Servants shall be obedient to the Wardsmen, Regulations of the Institution, and they shall report immediately to the Resident Surgeon, House Steward and Dispenser, or Matron, any impropriety of conduct or infringement of them by any patient, visitor, or other person; and if such complaint be not properly attended to, they shall report the same to the House Committee at its next meeting.

Nurses, and Servants to be obedient to the Regulation; report impropriety and infringement.

PATIENTS.

- 43. Patients shall conduct themselves orderly, and shall strictly Conduct; observe directions. observe all the directions of the Resident Surgeon, House Steward and Dispenser, Matron, Wardsmen, and Nurses.
- 44. They shall take their medicines at the time directed, and they Medicines bra shall take no other medicines than those prescribed; and they shall not conceal nor put away any portion of the medicine or diet administered to them.
- 45. No one shall leave his or her ward, and go into another ward or Details respecting liberty to leave the Wards, abapartment, nor leave the house, nor remain out for a longer time than is sence, visitors, granted, nor shall introduce visitors, nor receive medicines, victuals, liquors, or any thing, without express leave of the Resident Surgeon or Secretary.
- 46. They shall not play at cards or dice, nor gamble or smoke, nor Details respecting spit on the floor, nor deface or injure any part of the ward, nor any furcleanliness and conduct. niture, bedding, or clothing therein, nor sing, blaspheme or use rude or indecent language.
- 47. No patient shall give reward or gratuity to any of the Wards- Notto give reward or gratuity. men, Nurses, or other servants.
- 48. Any patient having any cause of complaint shall make the same Regulations known to the Resident Surgeon, whose duty it shall be to enter such complaint immediately, in the presence of the nurse or wardsman of the ward, in a book kept for that purpose, which book shall be laid before the House Committee at each meeting.

- Employment of 49. Patients judged by the Resident Surgeon sufficiently convalestients. cent to be able to assist in the work of the Institution shall be so employed.
- Regulations respecting rising o'clock in the summer; and all patients considered by the Resident Surgeon able to do so, shall rise by 7 o'clock in the summer, and before 8 o'clock in the winter.
- Venerial patients. 51. No venerial patients shall be admitted a second time, having been once under treatment and cured.
- Patients offending 52. Every patient offending against the above regulations will be against the redischarged for irregularity. discharged.

VISITORS.

- When admitted; visits limited to one hour.

 53. Visitors are admitted into the Institution on Sunday and Thurson hour.

 but no visitor is allowed to remain more than one hour. Not more than two visitors will be admitted to see each patient, except on special occasions, and by the leave of the Resident Surgeon or Secretary.
- Special visits. 54. Visitors may be admitted on special occasions by a written order from a member of the House Committee, addressed to the Resident Surgeon or Secretary.
- Regulations re- 55. Visitors will not be allowed to go into any ward without the specting visits. leave of the Resident Surgeon or Scoretary; and every visitor must retire when requested.
 - 56. They will not be permitted to give to, or leave with any patient any money, medicine, food, or liquor of any kind, nor any other thing without the express sanction of the Resident Surgeon. Any one doing so will not be again admitted.
- Not to give money 57. No Visitor shall give to any Servant of the Institution any or gratuity money or gratuity of any kind.
- Not to interfere, 58. Visitors are requested not to interfere with the Wardsmen or etc.; quietness. Nurses, and not to disturb the patients by loud talking or unnecessary noise.
- Respecting visitors violating any of the Regulations of the Institution, the regulations or behaving with impropriety, will be compelled to retire, and will not or behaving im- be re-admitted without special leave from the House Committee.
